The project itself is of national importance because it will create a base of information for each protected area, maps, videos, 360° photography that will create National Atlas of nature values and protected areas that will be used to raise the awareness on national level about the importance of the PAs, but will also be used for local economic development, entrepreneurship and green businesses creation, tourist information and education. All protected areas will benefit by getting a visual promotional identity and will be part of a joint communication strategy for all PAs. Protected Areas hold great potential to support sustainable tourism and local development. These opportunities for them remains underused and under promoted. Additionally, it is a general conclusion that local people are not involved in the management of the Protected Areas, but they partially use/abuse the ecosystem potentials of the PAs for generating personal income. This way of utilizing the ecosystem services cannot initiate local economic development, support green businesses establishment and catalyze sustainable tourism and sustainable use of ecosystem services. This project will bring many benefits for the local people and the environment promoting the Protected Areas through joint communication platform on one national level.

- 1) Communication, education and public awareness raising (CEPA)
- 2) Sustainable tourism and recreation development
- 3) Monitoring of species and habitats.
- 4) Creating national platform for other "Improving the management of protected areas" UNDP initiatives in frame of the web and mobile platform

- Established "two-way" communication system between PA and all potential visitors and tourists.
- Local people will benefit from this project.

- Local people will benefit from using more sustainable methods and they will save money by using free platform to promote their PA.
- The many rare and threatened species that live in PA will have a much better cohabitation in their natural habitat.

The new platform has to be Interactive web platform, an Atlas of national protected areas and potential Natura 2000 sites. The most significant protected areas will be presented through a factsheet or ID card. This activity involves preparation and design of national information platform that will provide knowhow about the PA, will present the PA to the general public and









will inform the potential visitors about the PA values.





To further enhance the new site and ensure the best experience to users, the Knowledge and Innovation Team is planning to conduct a series upgrades on the website.

The primary users of the site will be general public across the globe.

- Add a comprehensive search functionality to the web site
- Provide unlimited number of pages and their editing
- Possibility for WEB payment and WEB Shopping

The company will develop a graphic concept and the visual language of the new templates.

Ensure a consistent visual language on the new site by introducing fixed styles in templates ensuring consistency in fonts, formatting, icons, images, layout techniques.

The look and feel should be adapted to homepage, sections, subsections and the following components of the site: article template, resource webpage template, publication/guidance webpage template, country story webpage template, event webpage template.

Standard page elements including header, footer, tabs, persistent navigation, contact us, email and page print options should be included in the new templates.

The new templates should guarantee that most recent content on the site is captured in automatically in the homepage in an organized way following specific categories, tags or other custom taxonomies.

All section and subsection webpages should incorporate functionalities to guarantee the latest information on that section and sub-section is displayed (news, resources, publication/guidance, stories, and events).

The database of the NATIONAL ATLAS OF PROTECTED AREAS -NATURE.MK site must include possibility for new categories to display the information in an organic. Implementing (https) internet communication protocol that protects the integrity and confidentiality of data between the user's computer and the site.











Implementing security modules (firewall, fail2ban, malware, virus protections...).

Deliverable 2 - Knowledge transfer

Develop a user manual and deliver a webinar for the support staff and system administrators to perform content upload, system maintenance and administration.

Deliverable 3 - Support and maintenance

Support and maintenance: Administrative and technical support, quality control for a period of 18 months;

Deliverable 4 - Source code handover

Full source code including all developed libraries shall be handed over to NATIONAL ATLAS OF PROTECTED AREAS -NATURE.MK
